Clare's work was discussed and praised at the SIM meeting yesterday. Tests have been carried out earlier today observed by someone from the agency. No issues arose.

Staff are now better prepared to talk about those children who aren't achieving and groups of children can be targeted with interventions.

MB asked about the two children at KS1 that are struggling with maths. MC said that 2 interventions had been put in place and further assessments will now be carried out. The Sandwell test will be used.

Early years

Sarah has targeted:

- 83% Reading
- 79% Writing
- 83% Maths

MC reported a good level of development and is confident that these targets will be achieved.

There is no prior assessment for early years. MC explained that the government had brought in a baseline but this has been withdrawn. The purpose was that progress could be checked, not just attainment. There were three assessments available but were not compatible with each other so results couldn't be compared.

Targets for KS1 can be based on what was achieved at the end of EY.

HT asked how the issue raised by Ofsted of not challenging children has been addressed. MC and NW gave a comprehensive overview of how challenge and choice have been introduced enabling and encouraging children to take responsibility for their own learning. The big difference is how children now talk about their learning and realise they are being challenged.

7 Post Ofsted plan (incorporating SIP)

This had been discussed at the SIM meeting. This is a regular item with SLT and MC has annotated the plan with updates. All items are on track to be completed. There are one or two small things, such as moderation with Milnthorpe, where actions are dependent on someone else. A joint staff meeting with Milnthorpe is organised.

There are a few governor items that need to be updated, including:

- Clarification of link governors
- Governors to be fully involved in re-visioning
- Setting up and maintaining a record of governor training

MB asked that an update be presented at the next FGB.

MC informed governors that Safeguarding training has been arranged for 1 September at 1.30 pm. Governors are invited to attend.
